


Development of a legal concept for the redevelopment of the territory of the pioneer camp with an area of 138,000 sq.m. in the recreational zone of the Moscow region in the interests of a large industrial holding. Representing the interests of the developer in a dispute on the claim of a municipal authority for the recovery of 154 million rubles of losses caused by non-fulfillment of an investment contract for the construction of low-rise residential buildings and infrastructure.
